Pursuant to the Georgia Open Records Law (O.C.G.A. 50-18-70 et seq.) (the "Law), as well as O.C.G.A. 45-6-6, you are hereby requested to make available for review and copying all files, records and other documents, by electronic means if possible, in your possessions, or in the possessions of another agency, department, or, that refer or relate to the following numbered ORR listed below. This request includes, but is not limited to, all documents, notes, correspondence and memoranda evidencing interaction; and all communication and correspondence in whatever tangible medium between and among the below numbered request and without outrageous, unreasonable, and intimidating charges placed as road-blocks to this citizen's request.

If this request is denied in whole or in part, we ask that you cite in writing the specific statutory exemption upon which you have relied, as required by law. We also ask that you release all separate portions of otherwise exempt material. Please waive any costs associated with this request, or first inform us about such costs as required by law.

As you know, the law requires a response by you within three business days of your receipt of this letter or e-mail (the Attorney General's Office has ruled that e-mail correspondence satisfies the legal term of letter), and provides sanctions for non-compliance. Please provide the following numbered GORR:

1. .A list of all vendors doing business with the BoR & all Universities, Colleges, et al over the past ten years.
2. All businesses connected to Donald M. Leebern Jr. & family doing business with the BoR & all universities, colleges, et al.
3. All information should provide yearly cumulative totals paid to Leebern's companies... by the State of Georgia treasury, to include checks from all entities with state and under the obligation to GORA, to provide such information.

4. All information regarding all listed Leebern companies, as well as any companies not listed, in this GORR: Georgia Crown Distributing, Georgia Crown Corporation, Melwood Springs Water, Dahlonga Pure water, Jax Entertainment, Logicscare, Inc., J & L Ventures SUB I & SUB II, Georgia Wholesale Distributors, GCDC Venture I, GCDC Venture II, Firestone Winery, PPG Properties LLC, et al.

I sincerely hope the State of Georgia Board of Regents & any other state agencies that are required, by law, to respond to the GORA, will communicate with the Ethics in Government Group, within 3 business days.
